#### Membership


As of May 2016, 79 members representing:

- JISC



# IG Working Group meetings

- 15th October 2015
- 21st March 2016

- Increasing representation of HSCIC divisions
- Good attendance (~20 in March)

## Developments

- Review of the Data Sharing Framework Contract and Data Sharing Agreement, Oct 2015
  - Institutions contributed individually
  - IGWG provided summary response
- Audits have commenced (approx two HE toolkits per month)
  - Positive experience
- Next version of the Toolkit likely to have minimal changes pending Caldicott 2

## Main topics

- Consistency of approach to HE
- Federated nature of HE
  - Communications and authorisations
  - Reissuing Framework Agreements for new studies
- Accommodation of feedback from survey
- Disparate nature of HSCIC

## Sample issues in focus

- Retention of source data for research: deletion notices vs retention schedule
- Addition of technical requirements to framework contracts (e.g. on encryption)
- Handling of "old consent" situations
- Use of the IG Toolkit or ISO/IEC 27001 or "other" to satisfy contract

## Other developments

- Further divisions of HSCIC to be invited to participate in IGWG
- Letter is now sent by HSCIC to new and existing IGTK registrants inviting them to join the IG Working Group
- To liaise with HSCIC regarding anonymisation/pseudonymisation standard
- Caldicott 2 on hold pending referendum

## Next steps

- Work with HSCIC to resolve current issues
- Prioritise main topics ongoing
- Contribute to development of anonymisation/pseudonymisation standard
- Arrange more workshops and training days

- Successful collaboration with HSCIC on the Toolkit
- Challenges persist relating to Framework Agreement
- Working Group would propose to continue in operation

- Ongoing discussions with HSCIC regarding contracts
  - Existing contracts being extended
- Using external consultant to assess requirements against Attainment Level 3

#### ISO/IEC 27001 News

- Surveillance audit passed in April 2016
- Certified for 2 years so far
- New operational ISMS management team
- Challenges in funding and identity of "top management"
- Joined-up thinking crucial
- Considering "IT department as service provider" approach
- Looking at tools for ISMS records management
